## 65th Anniversary celebrated

His Excellency the President of the Republic of Fiji Major-General (Ret'd) Joji Konrote, CF, OF (Mil), MC, SBSt.J, MSD, OMRI, NOC was Chief Guest at the JP Bayly Trust's 65<sup>th</sup> Anniversary celebrations held at De Vos in the Park, Suva on November 21<sup>st</sup> 2019. He was accompanied by the First Lady, Madam Sarote Konrote.

About 80 guests who included all the Trustees, the General Manager, three divisional Managers, staff, Committee members and volunteers from Labasa, Lautoka and Suva as well as other invited guests attended. The Mistress of Ceremonies was the celebrated Mrs. Bernadette Rounds-Ganilau.

In his address the President stated, "Ni sa bula vinaka and a very good evening to you all. My wife Sarote and I are indeed honoured and very appreciative of the kind invitation extended to us on this auspicious occasion that marks the 65th Anniversary of the JP Bayly Trust and to be amongst you all.

Ladies and gentlemen, as most of you know and this is perhaps why so many of

Email:admin@baylytrust.org (General Manager, John Yee) you good people have been involved with the Trust which was established in 1954 by the late John Percy Bayly OBE and the late Reverend Dr. George Hemming CF, OBE to provide much needed assistance to the less fortunate families in Fiji.

Registered as a Charitable Trust on July 30<sup>th</sup> 1954, the Welfare Center began providing food packs to several families who were living below the poverty line. The Bayly Medical Clinic opened in Suva in November of that year with Lautoka in 1987 and Labasa ten years later.

Administered by a Board of five Trustees who are all appointed in a voluntary capacity and receive no compensation either in cash or in kind, there is a General Manager with Managers based in Suva, Lautoka and Labasa.

The Current Trustees are Mr. Digby Bossley (Chairman), Mr. Waqa Bauleka, Mr. Joel Sahai, Mrs. Viti Whippy and Mr. Barry Whiteside.

Also, all divisions have local Committees comprising dedicated persons from within the community and the Centers are assisted each week by a group of Volunteers for packing and distributing food packs and other items.

The Trust has Medical and Dental Clinics operated by registered Practitioners, Welfare and Education Centers in the three divisions whose geographical boundaries have recently been extended in order to assist more families. The Clinics provide free medical and dental consultations as well as medication to just over 400 families who are permanently registered with each Center.

The Welfare Center gives

out monthly food packs, footwear, bedding and clothes throughout the year to these less fortunate families. In addition, there are several temporary cases with each Centre who also receive similar assistance.

The Education Center assists their children with Kindergarten, Primary and Secondary schooling needs by way of fees where applicable, uniforms, shoes, bags, stationery and exercise books. Also, several of their children in Tertiary institutions have their fees and other requirements paid for by the Trust.

Although assistance towards Tertiary education has been in place for the past year with just a selected few being supported, this has now become an annual award from 2019 and is offered to those with exceptional academic results in year thirteen and who are keen to pursue higher studies. Currently there are nine students on full Tertiary scholarship and many more will be offered assistance in 2020.

Tertiary qualification is now a prerequisite in securing a decent employment

and the Trust believes that deserving students should not be deprived of further studies in their chosen field. This assistance is being offered for Certificate and Diploma courses and depending on the results of the student, may extend to a Degree level.

Recently, the Trust has also embarked on providing counseling in Positive Parenting for mothers and has already very successfully completed the first Workshop in Lautoka in October this year and the next one is planned for Suva and then in Labasa in early 2020.

With rising serious incidents of Drug and Substance Abuse as well as Child molestation by fathers and grandfathers that are viewed with grave concern, this is going to be another programme which the Trust will undertake. It has a qualified and an experienced Counselor who will provide her services in this area.

Typical of the Trust's guiding principles, none of the it's funds has been spent on tonight's celebrations and I therefore, acknowledge with great and sincere appreciation, the generous donors and friends of the Trust for sponsoring the invitation cards, the venue with the food and drinks. Thank you very much for your kind generosity.

To the Board of Trustees, Management, Volunteers, Committee members and staff from the Welfare Centers in Labasa, Lautoka and Suva, thank you all for your hard work, sacrifices and commitment towards such a worthy cause.

#### Skills for Positive Parenting

The Lautoka Bayly Welfare Center had a two day Workshop in October this year on "Building Skills for Positive Parenting" and attended by some of its lady recipients.

It was an opportunity for them to reflect on their parenting skills to see what has been working well and what may not be. The intention was to discuss and share some thoughts to strengthen their parenting skills which would help in raising confident, strong and happy children who would later grow to become productive adults and respond well to the challenges that life may throw at them.

A total of 10 women were part of the programmme; 8 from different areas around Lautoka, the Chairperson of the Welfare Committee Stella Smith and me. After the first day, the women were all talking about how they were learning from it. "It is very interesting and challenging! We wish we had done this earlier", they said.

After the Workshop, everybody was excited and talked about how it had been an eye opener; how it had helped them to better understand the development stages of a child; the types of parenting style and what form of parenting style they were using; the different types of families and their roles; the importance of family values; how their kind of parenting can affect their children

in a negative or positive way and it taught them the importance of their support towards their children's life as a whole.

The parents felt empowered and are looking forward to put into practice what they have learnt as they know it will be challenging but are positive in knowing that nothing is too late.

For me personally, after attending this Workshop I was happy that I have learnt a lot especially in understanding my work better. As a Manager, the cases I get every day usually challenges me but after going through this Workshop I can better understand our parents as well as my own frustrations and how it relates to our parenting and the upbringing of our children especially in their development stages.

Looking at how this training is helping me in the work that I do I am excited. We are lucky to be part of this since it's a paid training and thanks to the Counselor Kelera Batibasaga who facilitated the sessions. Now I am looking forward to having another for 10 other women as I really want all our parents and care givers to attend this training.

Many cases come up regarding our children's behaviour and we actually support the negative without realising our input into that behaviour. We forget that we are the ones that our children are learning from as their first school is at home itself. We don't realise how our parenting is affecting our children, their school work and their life. We tend to blame them for their weakness but little do we know that we and our parenting style is the biggest contributing factor towards that.

In Positive Parenting training we learn a lot of things and are happy that we were part of it.

After completing her studies Warsha is now legally married to Jason Sami and waiting to migrate. She has assured us that being married and migrating will not until her bonds with the JP Bayly Trust and we wish her all the best in the future.

## ANZ Staff Foundation funds Sanitation Projects

#### Where there's a Will there is a Way

A family of 4 children with a mother and a grandmother, residing in Kalekana Village settlement, just beyond Lami town, found life so miserable when they had no floor in their kitchen. The toilet was so far, similar to most villages and a 44 gallon drum was used for collecting water to have a bath, but waiting for night to come as their bathroom had neither any walls nor a roof.

Providing food on the table and looking after the education of the children has been an ongoing program for JP Bayly Trust for the last 65 years. Something extra if possible and why not give it a go, I thought and didn't sleep over it until a project was planned.

We got it approved by the Suva Welfare committee and submitted our proposal to the JP Bayly Trust Board. Yes, it was approved and I was given a challenging task to take it on.

I was so fortunate to receive a donation in kind by Trust Chairman Mr. Digby Bossley, my Tenants and a Volunteer Mr. Mahen Bali who gave his time and labor in getting this project started. Not forgetting Mr. Michael Chandra who has been supporting me tirelessly as this project was not easy and I would say very time consuming.

Nevertheless all was done for a good cause and seeing a family in comfort gives us joy and satisfaction.

#### **Professional Counselor services**

Kelera Batibasaga, who has a Diploma in Professional Counseling from the Australian Institute of Professional Counselors, has commenced her counseling services at the JP Bayly Clinic in Lautoka.

She has offered to provide her services to the Bayly Welfare Centers in Labasa, Lautoka and Suva on Positive Parenting, Drug & Substance abuse as well as Child Molestation and has already conducted a two day workshop for mothers on Positive Parenting in Lautoka.

Kelera also holds a Diploma in Education from the South Pacific Christian Teachers College as well Diplomas in Legal Studies, Psychology, Biology and Behavior in Psychology and Memory & Cognition in Psychology, all from Alison, Galway, in the Republic

#### Support for tertiary education

The JP Bayly Trust has been given a grant of \$194,706.00 by the Jaycees Trust towards assisting less fortunate students who have a desire to pursue higher studies after completing year thirteen of schooling. This will be for Certificate, Diploma or Degree levels.

The Jaycees Trust had decided to grant 50% of its balance of funds to the Bayly Trust and the other half to another organization. It has been named the Jaycees Scholarship Fund and the Bayly Trust has the discretion to use it to benefit students in the Central, Western and Northern divisions.

In order to maintain a longer sustainability of the fund, students will be required to repay 60% of the grant awarded to them after successfully completing their studies and getting employed. They will repay a percentage of their salary over a period of time.

The Trust wishes to express its very sincere appreciation to the Jaycees Trust for this generous grant.

## Boost for Trust of \$20k

The JP Bayly Trust has received \$20,000.00 from the Vodafone ATH Fiji Foundation for education assistance to less privileged students.

The handover was done by the Foundation's Executive Ms Ambalika Devi at the Trust's office in late October of this year and acknowledged by Trustee Viti Whippy and the Manager Central, Manorma Chandra.

Mrs. Chandra said that the Bayly Welfare serves around 700 people each month in the three Centers in Labasa, Lautoka and in Suva with each Center recording about 200 to 300 needy cases. "The major challenges for most of these families who seek assistance were the cost of living and unemployment".

"The Trust assisted those who did not receive any welfare assistance or food vouchers as well as families where the breadwinner had lost his or her work. We provide food packs as well as meet the educational needs of the children in addition to free medical and dental services and medication". "One of the biggest challenges is dealing with unscrupulous and dishonest claimants. There are several people who lie about their situation in an attempt to

take advantage of the assistance provided. If they receive money

or food vouchers or old age pension from the Social Welfare department, they come and tell us that they do not receive any", Mrs. Chandra concluded.
