### Service to the community

Originally from the Garden island of Taveuni and after completing his secondary education at the Lautoka Muslim High School and Labasa College, Dr. Kishor was awarded a scholarship to study dentistry at the Fiji School of Medicine. He graduated in 1980 and served his internship at the CWM Hospital in Suva.

In pursuit of furthering his services, Dr. Kishor applied to join the Republic of Fiji Military Forces to serve either in Lebanon (UNIFIL) or Sinai (MFO) and was selected for UNIFIL. He served as the Regimental Dental Officer in the Fiji Battalion 9 for a year from 1985 to 1986, holding the rank of Captain.

"It was a good experience with some degree of danger while on tour of duty. It also taught me punctuality, discipline, value of life and endurance, being away from the family", he told *Bayly News*.

Dr. Kishor has been offering free dental services to the less fortunate and disabled, including the Labasa Bayly Welfare recipients ever since he opened his practice in 1990. "I derive great satisfaction in providing a very essential dental service to the community and the country", he commented.

"Bayly Welfare recipients are treated with the same diligence and professionalism as any other patient who comes to both the Labasa surgery as well as the Suva Bayly Clinic. Treating underprivileged members of the society at no or minimal cost, gives us a lot of satisfaction. Dr. Shivaan also treats each patient with dedication, compassion and humility and has good public relations with all his patients".

Being one of the only two dental surgeons in private practice in Labasa, Dr. Kishor attends to an average of 100 patients in a week. Without a full time technician, he also engages in making dentures himself which keeps him extremely busy.

Asked about his future aspirations he answered, "To continue to provide dental services to our people until my retirement and to make people dentally conscious of the importance of teeth. Dentistry is not expensive but neglect is".

Besides being a Dentist, Dr. Kishor has an avid interest in painting and over the years,

has produced several oil paint creations. Being raised on an island surrounded by sea, it is not surprising that he should list his favourite hobby as fishing, using his own boat and fine art painting.

His surgery is located in Savilla House in Labasa town which is named after his wife Savilla Devi. They have been married for 36 years and have a son Dr. Shivaan Kumar and a daughter who lives in Melbourne, Australia and have two young grand daughters.

# Food packs provide all the basic nutrients

The National Food & Nutrition Centre (NFNC) of the Ministry of Health & Medical Services recently completed an analysis of the food pack which the three Bayly Welfare Centers distribute to about 400 less fortunate families registered in Suva, Lautoka and Labasa. It also recommended changes necessary to improve the nutrient contents and the JP Bayly Trust can then determine if the packs are adequate or it needs to re-adjust the quantity.

The Trust has an assessment of the food packs carried out by the NFNC every three to five years which currently includes Rice, Flour, Dhal, Sugar, Tea, Cooking Oil, Blue Peas, Tin Fish, Biscuits, Eggs, Salt, Potatoes, Onions, Powdered Milk and Rolled Oats. The pack is designed to complement what the recipients are able to source on their own and given out once a month and the size is dependent on the number in each family.

The NFNC report states the food ration given by the Trust, ".....provided all the basic nutrients in varying amounts. The basic food constituents of the current food rations appear sufficiently varied and appropriate, given the family situation. JP Bayly Trust is achieving its goal. The basic food items in the current food pack appear adequate in terms of providing some amount of essential nutrients".

The report also asks the Trust to consider re-examining the packs based on available funding for:-

a. Frequency of distribution to either fortnightly or 3 weekly; or

b. Increasing the amount of food in the current pack by a third and maintain the present distribution frequency; or

c. Explore other opportunities to increase food security in the community as the current pack is high in carbohydrate sourced foods and very limited in vitamins and minerals that are available

from vegetables and fruits. Empowering communities to have food gardens and having assistance programmes to source seeds and planting materials would be an option that the JP Bayly Trust can explore.

It further states that for good health, the World Health Organisation recommends that the total energy intake contributed by macronutrients be (carbohydrate 55% to 70%, protein 10% to 15% and fat 15% to 30%). The total energy provided by the JP Bayly Trust food pack is 24,825.70 kilo calories, a slight increase from the food pack provided in 2014 which was 23,032.72 kilo calories.

The average daily intake by a person should be between 1,800 to 2,100 kilo calories. The assessment by the NFNC was based on the quantity given to each family.

The Board of Trust and the three divisional Managers will consider the report as well as the recommendations in a joint meeting later this year.

# 65 years dedicated to the less fortunate

This year marks 65 years since the JP Bayly Trust was established in 1954 by the late John Percy Bayly OBE and the late Rev. Dr. George Hemming CF, OBE to provide much needed assistance to the less fortunate families in Fiji. Registered as a Charitable Trust on July 30<sup>th</sup> 1954, the Bayly Medical Clinic opened in Suva in November of that year with Lautoka in 1987 and Labasa 10 years later.

Administered by a Board of five Trustees who all are appointed in a voluntary capacity and receive no compensation either in cash or in kind, there is a General Manager with Managers based in Suva, Lautoka and Labasa. Current Trustees are Digby Bossley (Chairman), Waqa Bauleka, Joel Sahai, Viti Whippy and Barry Whiteside.

Also, all divisions have local Committees comprising dedicated persons from within the community and the Centers are assisted each week by a group of Volunteers for packing and distributing food packs and other items.

It has Medical and Dental Clinics operated by registered Welfare Practitioners, and Education Centers in the three divisions whose geographical boundaries have recently been extended in order to assist more families. The Clinics provide free medical and dental consultations as well as medication to just over 400 families who are registered with each Center while the Welfare Center gives out monthly food packs, footwear and clothes throughout the year.

The Education Center assists their children with Kindergarten, Primary and Secondary schooling needs by way of fees where applicable, uniforms, shoes, bags, stationery and exercise books. Also, several of their children in Tertiary institutions have their fees and other requirements paid for by the Trust.

Tertiary qualification is now a pre-requisite in securing a decent employment and the Trust believes that deserving students should not be deprived of further studies in their chosen field. This assistance is initially being offered for Certificate and Diploma courses and depending on the results of the student, may extend to a Degree level.

## Tertiary assistance begins in earnest

As the Trust rolled out its assistance with tertiary education for 2019, nine students have been awarded funding to pursue courses leading to a Certificate, Diploma and a Degree.

Tertiary qualifications are now an important requirement in securing a decent employment and the Trust believes that deserving students should not be deprived of further studies in their chosen field.

The applicants undergo a rigorous family background check, including financial assessment by the divisional Managers in Suva,

Lautoka and Labasa before submission and final approval by the Board.

The Trust continues to offer assistance to children from around 400 registered families in the three divisions from Kindergarten to year thirteen which includes the provision of all their schooling needs. In addition to members of their family, the students also receive monthly food packs, free medical as well as dental consultations and treatment, medication and professional counseling. Assistance provided for 2019 were to:

The remaining four were assisted with an advance by the Trust, pending remittance of funds from a prospective donor. The assistance also includes travel expenses from home to the Institution and return.

### A new wheel chair finds a home

Areport in the print media in early July promoted the Manager Western of Bayly Welfare Sarojani Michael, to intervene and provide a much needed wheel chair to Kamni Krishna at her Lovu HART home in Lautoka.

The chair she was using was old and squeaky and was given a brand new one as a replacement. The 35 year old Kamini, who is physically handicapped, was most appreciative with her mother, Saraswati commenting that Kamini was so happy, smiling and laughing.

"We read about the case and decided to help", said Mrs. Michael. "The family receives \$80.00 each month from the Social Welfare department out of which \$30.00 goes in rent and about \$25.00 for electricity and water. With other basic expenses such as food the family's monthly expenditure is around \$112.00".

"Andrea June, a student at the University of the South Pacific was able to witness first-hand the joy of giving and receiving. During her care giving course at the University of the South Pacific, 32 year old Andrea must have clocked up to 40 hours of practical work over the course of 3 days in a week".

"She was given a wonderful opportunity to utilize her knowledge and compassion in care giving with Saraswati and her daughter Kamini Krishna who has been confined to wheel chair from early childhood and as time went by wheel chairs came and went".

Andrea was amazed to see that such a place as the Bayly Welfare in Lautoka existed and was very impressed with the good work it carried out. When she left for the Lovu HART village, she was expecting a normal day but was in for a big surprise when Mrs. Michael handed over the new wheel chair. Andrea commented, "Kamini was filled with joy and couldn't control her giggles".

### Donors can receive a Tax benefit

If a Fiji registered company makes a donation to us it is entitled to use this as a legitimate expense to reduce its tax liability. The **Bayly Welfare** is an approved charitable organization with the Fiji Revenue & Customs Service for tax purposes.

A proposal was made to the Foundation late last year and after working out all the logistics a cash donation of \$11,585.00 was allocated to the Trust. All staff contribute \$2.00 each fortnight towards the fund and the Foundation then decides the amount to be donated to whichever organisation.

The Trust believes that education is of paramount importance and once a child gets educated and secures a decent job, he or she is able to take their family out of the poverty cycle. The Foundation has carried out several projects in various communities and assisted many organizations.

Some funds will also be used to carry out sanitation projects for women's groups as requested by the Foundation. The Bayly teams in Labasa, Lautoka and Suva would like to thank the ANZ Staff Foundation for providing this timely donation and we will ensure that it is used where the need most exists.

Once again, a big *Vinaka vakalevu* and may the Foundation achieve continued success in all its endeavours.

S ulueti Nada, a single mother of three young children and living in Lovu HART Home in Lautoka, was recently given a much needed sewing machine by the Bayly Welfare team to help her have a brighter future with her sewing business. During our visit she was

very emotional, talking about what she went through and how they were surviving with the little that they receive.

Very creative with her hands, she showed us some of the stuff that she worked on but now couldn't continue because the machine that she was using had been taken back by her friend. Sulueti has no support network and therefore, cannot go out and work, leaving her daughters with a stranger.

Since she knows how to sew, the Bayly team came up with the idea of donating a sewing machine so she can work from home and also care for her two younger daughters.

The team is well aware of the Child Protection Policy,

therefore its decision to donate a sewing machine will actually cover both areas of our welfare work including child protection.

We will also be assisting her with welfare and education support as she finds that the financial backing she currently receives is not enough for her and her daughters, given the rising cost of living.

This is our Trust's policy - to get individuals and families out of the poverty cycle and who so ever comes to our door is not sent away empty handed. So, we at Bayly Welfare are always there in time of need and will also arrange sessions for her with our Counselor Kelera Batibasaga.
